

ELEAGUE: STREET FIGHTER V AMATEUR CONTEST TURNER STUDIOS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE CONTEST. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE ENTRANTS' CHANCES OF WINNING. THIS IS A SKILL-BASED CONTEST. VOID WHERE PROHIBITED BY LAW. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY / PRIZE ACCEPTANCE IS REQUIRED. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT. SPONSOR (DEFINED BELOW) OBTAINS RIGHTS FROM ENTRANTS TO POST, BROADCAST AND USE ANY AND ALL CONTENT SUBMITTED AS PART OF THE CONTEST.

BY ENTERING (OR OTHERWISE PARTICIPATING) IN THE CONTEST, ENTRANTS AGREE TO THESE OFFICIAL RULES, WHICH CREATE A BINDING CONTRACT. SO, READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, SUCH CONTRACT INCLUDES GRANTS OF RIGHTS AND RELEASES OF THE SPONSOR AND OTHERS FROM ENTRANTS AND A LIMITATION OF ENTRANTS' RIGHTS AND REMEDIES.

ELIGIBILITY: Subject to the other terms herein, the ELEAGUE: Street Fighter V Amateur Contest (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older (or the age of majority in such entrant's state of residence, whichever is older) and rightfully in attendance at the ELEAGUE: Street Fighter Amateur Tournament on June 1, 2018, June 8, 2018, June 15, 2018, June 22, 2018 and July 13, 2018 (the "Event Date(s)") at the ELEAGUE Fan Zone at Turner Studios (i.e., prior to entering the Contest, have a valid ticket to the ELEAGUE: Street Fighter V Playoffs on the Event Dates at Turner Studios). Employees of Havoc Live, LLC dba IMG LIVE ("Sponsor"), Sponsor's partners (including, without limitation, Turner Sports, Inc.) and their respective parents, subsidiaries, affiliates, Contest and advertising agencies and members of their immediate family (spouse, parent, sibling or child and their respective spouses, regardless of where they reside) and persons living in the same household of the foregoing, whether or not related, are not eligible to enter or win the Contest. The Contest is void where prohibited by law. The Contest is subject to all applicable federal, state, and local laws.

HOW TO ENTER: Individuals attending the live broadcast of the ELEAGUE: Street Fighter V Playoffs on the Event Dates at Turner Studios will have the opportunity to enter the Contest. Limit of one (1) entry per individual. All individuals participating in the Contest must enter between _____. Contest gameplay will begin at _____ (Sponsor's clock will be the official timekeeper of the Contest). As soon as possible upon arrival at Turner Studios, entrants must register with Sponsor's Contest representatives at a marked desk in the "fan zone" by filling out a Contest entry form (which may ask for, among other things, entrant's full name, address, etc.) to enter into the Contest. Once entered into the Contest, each entrant will play one (1) round of Street Fighter V (the "Game"). Eligibility of individual entries will be at the sole discretion of Sponsor, for any reason or for no reason, though specific reasons for disqualification may include use of inappropriate language and/or violence against other contestants (e.g., without limitation, (e.g., making indecent, sexually explicit, derogatory, racist, sexist, etc. comments to others). No purchase or payment of any kind is necessary to enter or win the Contest. Must have a ticket to enter the Event. A purchase or payment of any kind will not increase entrants' chances of winning. The Contest is skills-based.

GAME FORMAT AND WINNERS: Each player in the Contest on an Event Day ("Contestant") will be paired with another Contestant (the "Match"). The Match will play the Game according to the settings chosen by Sponsor in its sole discretion. The winner of each Match will advance to the next round and be paired with another Contestant. The Contestant will continue to face opposing Contestants until no further Contestants are left. The last Contestant left will be considered a "First Place Winner" and the runner up the "Second Place Winner".

WINNER NOTIFICATION: The winner of the Contest will be announced on each Event Date following the conclusion of the Contest.

PRIZING: The First Place Winner of each Contest on June 1, June 8, June 15, and June 22, 2018 will be awarded with a \$150 gift card. No compensation will be paid in lieu of a lost or destroyed Prize. Approximate Retail Value ("ARV") of the Prize is: One Hundred Fifty Dollars (\$150) per Event Date listed above. The Second Place Winner of each Contest June 1, June 8, June 15, and June 22, 2018 will be awarded with a \$50 gift card. No compensation will be paid in lieu of a lost or destroyed Prize. ARV of the Prize is: Fifty Dollars (\$50) per Event Date listed above. At

the Event on July 13, 2018, The First Place Winner of each Contest will be awarded with a \$300 gift card. No compensation will be paid in lieu of a lost or destroyed Prize. ARV of the Prize is: Three Hundred Dollars (\$300). At the Event on July 13, 2018, the Second Place Winner will be awarded with a \$100 gift card. No compensation will be paid in lieu of a lost or destroyed Prize. ARV of the Prize is: One Hundred Dollars (\$100). For the July 13, 2018 Event ONLY third place winner (“Third Place Winner”) and fourth place winner (“Fourth Place Winner”) will each receive a \$50 gift card. No compensation will be paid in lieu of a lost or destroyed Prize. ARV of the Prize is: Fifty Dollars (\$50).

Except where prohibited or modified by applicable law, the Prize is valid through the expiration date shown on the front of the Prize (if any) or until the balance of the Prize is depleted. The Prize is accepted anywhere Visa cards are accepted, but cannot be: (i) redeemed through Sponsor for cash; (ii) re-loaded with additional funds; or (iii) used at an ATM.

PRIZING CONDITIONS: By entering or participating in the Contest, entrants agree to be bound by these “Official Rules” and the decisions of the Sponsor, which are binding and final on matters relating to the Contest, including, without limitation, interpretation of these Official Rules. If Sponsor uses any information of an entrant provided during the Contest entry process, Sponsor will do so in accordance with its privacy policy or that of an affiliate, each of which is available upon written request to Sponsor. All Prize details not specified in the Official Rules will be determined in Sponsor’s sole and absolute discretion.

Prior to being deemed the official Prize winner: (i) the potential Prize winner must present state authorized identification; and (ii) the potential Prize winner will be required to execute and return a release agreement (collectively, “Prize Acceptance Documents”), in each case, immediately after being named by the Judges as the potential Prize winner. Without limitation, if the Prize Acceptance Documents are not timely completed and returned, Sponsor is unable to contact a potential Prize winner, a potential Prize winner is not in compliance with these Official Rules, a potential Prize winner is found to be ineligible, or a potential Prize winner declines the Prize for any reason prior to its award, the applicable Prize will be forfeited and, at Sponsor’s discretion, an alternate Prize winner selected.

The Contest winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes), regardless of whether the Prize, in whole or in part, is used. The Prize (or any portion thereof) that may be awarded to the eligible winner is not transferable, redeemable for cash or exchangeable for any other prize, except in Sponsor’s sole discretion. If the actual value of the Prize is less than the stated Prize ARV, or the Prize winner does not use the Prize (or a portion thereof), the Prize winner will not receive the difference between the actual and approximate retail value, and such difference will be forfeited. The Sponsor reserves the right to substitute the Prize (or any portion thereof) with another prize of equal or greater value, for any reason, at the sole discretion of the Sponsor.

ENTRANT REPRESENTATION: Each Contestant represents and warrants that they will not cheat, and/or fix matches (e.g., equipment tampering, hacking, purposefully triggering a glitch, agreeing with another player to lose etc.). Such cheating is strictly forbidden and may lead to immediate disqualification of a Contestant from the Contest. Sponsor has the right to disqualify any Contestant at any time for suspected cheating and/or match fixing.

FURTHER DOCUMENTATION: If Sponsor shall desire to secure additional assignments, certificates of engagement for a Contest entry or other documents as Sponsor may reasonably desire in order to effectuate the purposes and intents of these Official Rules, entrant agrees to promptly sign and deliver the same upon Sponsor’s request.

ENTRANT RELEASE: By entering the Contest, entrants release and hold the Sponsor, Turner Sports, Inc. and any affiliated entities including parents, related and affiliated companies, subsidiaries, advertisers, broadcast partners, promotional agencies and each of their respective directors, successors, sponsors, partners, licensees, officers, subsidiaries, agents, employees, artists, artist entities, advisors, assignees, and all others associated with the

development and execution of the Contest harmless from and against any and all losses, damages, rights, claims, and actions of any kind arising in whole or in part, directly or indirectly, from the Contest or participation in any Contest-related activity, or resulting directly or indirectly, from acceptance, possession, use, or misuse of the Prize, including without limitation causes of action, claims and demands, including legal fees and expenses, including but not limited to, claims based on negligence, breach of contract and liability for physical injury, death, or property damage which the entrants or his/her administrators, heirs, successors or assigns might have or could have, by reason of or arising out of the entrant's participation in the Contest and/or in connection with the acceptance and/or use by entrant of the Prize.

WITHOUT LIMITING THE RELEASE GRANTED BY ENTRANTS HEREIN, BY ENTERING THE CONTEST, EACH ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, EXEMPLARY, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS, AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (B) ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

PUBLICITY RELEASE: By entering the Contest and unless prohibited by law, the potential Prize winner hereby consents to use of his/her respective name, biography, backstory, voice, recording, photograph and/or likeness for broadcast, advertising or publicity purposes for this and similar promotions without compensation and the potential Prize winner and guest will be required to provide a signed release acknowledging such consent, unless restricted by law. These Official Rules shall be governed by and construed and interpreted in accordance with the laws of the State of New York, U.S.A, applicable to contracts entered into and performed exclusively in that State, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.
